- I hereby request **registration** as an official American Legion Department of Nebraska Baseball Umpire for the 2012 season and enclose the \$35.00 application fee, completed application and 10 question test. I understand I will be provided one copy of the 2012 Nebraska American Legion Rulebook, an identification card for the current year, two American Legion Umpire patches (if a new umpire), and will be listed on an umpire roster, which is provided to all teams and Tournament Directors in May.
- All tournament umpires (Area and State) shall be **certified** by Department Headquarters. To be **certified** you must attend an **annual** American Legion sponsored umpire clinic/rules meeting and take a test prior to working any tournament games. **Part 2 exam is only given at the rules meeting and must be signed by a Liaison Umpire.**
- To be considered for assignment to work **AREA** tournaments, an umpire must be **registered and certified**. A list of area tournament directors will be provided and I am to make contact with them to be hired for an area tournament.
- To be considered for an assignment to work **STATE** tournaments, an umpire must be **registered and certified; have been an American Legion Umpire a minimum of five (5) years; and has umpired Area tournaments for at least three (3) years.** The Department Athletic Committee will select the State umpires at the June 2, 2012 meeting. Only certified umpires will be selected for State.
- After the first year of registration, all umpire patches must be purchased. Patches are available from department headquarters.
- DEADLINES:** May 21, 2012 – Umpires applying for state      June 18, 2012 – For area and regular season only umpires
- Starting in 2013 – All of the umpires officiating a regular season game will be required to be Registered and be Certified, see rule 9.0 in the NE rule book.
- Registered Umpires** – Fees paid, Registration and 10 question test filed with the Department. **Eligible for Regular season games Only.**  
**Certified Umpires** – Fees paid, Registration and 10 question test filed with the Department, attended an American Legion approved clinic and has taken part 2 of the test. **Eligible for Regular and all Post Season games.**
